DGM Membership Policies

Each facility and its owner are referred to in the agreement as the “Club” and for purposes of the provision of this Duncan Golf Membership Agreement, an existing membership is referred to as your “Membership” held by your name, the “Member”.

- I. At enrollment, the “Member” hereby agrees to pay the “Club” the one-time, non-refundable membership fee and the current month’s membership dues for the type of membership selected.

- II. “Member” is not liable for assessments arising from capital improvements, renovations, or repairs. However, such expenditures by the “Club” may influence an increase in the membership fee paid by new members or an increase in monthly dues. The “Member” agrees that monthly dues may be increased or decreased, in the “Club’s” sole discretions, and understand that such dues will probably increase during membership.

- III. To cancel the “Membership”, the “Member” will send a written communication to start the 30day cancellation process. Send notification to: Members@dmgolf.net

- IV. If “Member” cancels and returns to the “Club”; the “Member” will be considered a new member; therefore, the membership fee and monthly due will be due at time of rejoining the “Club”

- V. If the “Membership” account is current with no past due balance, the “Club” will honor a one-time, 6-month medical Leave of Absence (LOA). The “Member” will update the account’s balance before the LOA. The membership monthly dues will automatically resume after the 6-month medical LOA.
