Additional etiquette and guidelines:

- ► Stay continually aware of play behind them allowing faster players to play thru during their round
- ▶ Junior members under the age of 12 must be accompanied by an adult to access the golf course for play
- ▶ ALL Junior Members will have full access to the range 7 days a week
 - a. Range balls will be available in golf shop
- ▶ Must complete 10 rounds of golf in a year to qualify for membership the next year
 - a. If Member does not meet 10 rounds their membership may be forfeited and awarded to individuals on waiting list
- ▶ Appropriate attire is required when using facilities
- ▶ Tennis, athletic shoes or golf shoes required to use putting greens
- ▶ Each membership will be set up with a charge account
- ▶ NO range balls shall be taken to course for play
- ▶ Ability to book tee times 14 days in advance
